

## **JUMP!'S WIN A WEDDING RULES**

THE JUMP!'S WIN A WEDDING CONTEST (THE “**CONTEST**”) IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE “**CONTEST RULES**”).

**1. ELIGIBILITY.** To be eligible for this Contest, an individual must:

- (a) be a legal resident of the province of Ontario;
- (b) be of the age of majority or older at the time of entry;
- (c) be the sole owner of all right, title and interest (including copyright) in and to the Work (as defined below) submitted in connection with the Contest;
- (d) be willing and able to be legally married including without limitation the provision and completion of a marriage license and any necessary documentation for marriage in the province of Ontario;
- (e) be willing and able to accept the Prize as awarded; and
- (f) be able to redeem the Prize on October 24, 2020 in Ottawa, Ontario.

Employees of Corus Radio Inc. operating CKQB-FM (the “**Station**”) and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, “**Corus**”), Chic and Swell Inc. and its affiliates, subsidiaries, related companies, successors and assigns (collectively, “**Chic and Swell Inc.**” and together with Corus, the “**Sponsors**”), advertising and promotional agencies, judges of the Contest, and/or the household members of any of the above are not eligible to enter.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

**2. CONTEST PERIOD.** The Contest begins at 3:00 p.m. Eastern Time (“**ET**”) on September 4, 2020 and ends at 11:59 p.m. ET on September 23, 2020 (the “**Contest Period**”) after which time the Contest will be closed and no other entries shall be accepted.

**3. HOW TO ENTER.**

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.

- (i) To enter online, complete and submit the entry form located at <https://jumpradio.ca/contests/> (the “**Contest Website**”).
- (b) Each entrant must submit an entry form together with a ninety (90) second original video describing your relationship with your partner (the “**Work**”). The Work must be in the English language. Upload the Work to the Dropbox link provided on the Contest Website to enter.
- (c) By participating in this Contest, each entrant represents and warrants that the Work: (i) does not contain any material, language or gestures that are libelous, defamatory, indecent, profane, obscene or violent and does not violate any laws relating to hate speech or otherwise; (ii) is original, solely created by the entrant and that no third party participated as an author, co-author or otherwise in the creation of the Work or any part thereof, and all right, title and interest (including copyright) therein is owned and/or controlled by the entrant to the full extent necessary to enable the Sponsors to use the Work as contemplated by these Contest Rules; (iii) does not infringe upon the intellectual property right, proprietary interest or other statutory or common law rights of any third party; (iv) does not contain any recognizable logos or any other copyrighted material; (v) does not contain any mention, endorsement, or “plug” any commercial product, service, venture or thing, including, without limitation, the name of your employer; and (vi) has not been submitted in connection with any other contest and/or promotional campaign.
- (d) Limit of one (1) entry per person/couple during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (e) All entries including the Work, become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (f) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, “authorized account holder” of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

#### 4. **PRIZE.**

- (a) **Prize.** There is one (1) prize (“**Prize**”) available to be won by the Prize winner (“**Winner**”) consisting of:
  - (i) A Pop-up wedding to take place on October 24, 2020 (the “**Wedding Date**”) from 5:00 p.m. to 7:30 p.m. ET for up to 36 guests (including bride and groom) which shall include:

1. Wedding venue at 50 Sussex (50 Sussex Drive, Ottawa Ontario, K1M 2K1) for a thirty (30) minute wedding ceremony and two (2) hours dinner reception/speeches/first dance;
  2. Furniture rental by LouLou Lounge furniture rental including ceremony chairs, wooden pergola, two small lounge areas in reception level, wooden dining tables and chairs for 36 guests. Gold cutlery. Planters. Podium.
  3. Wedding decor provided by Avant Garde designs including the pergola decor & aisle runner for ceremony and for the reception level - ceiling treatment, all table décor (runners, centrepieces and candles), charger plates and goblets.
  4. DJ services for the duration of the 2.5 hours provided by Dynamix Productions;
  5. Touchless photo booth with custom template matching decor and featuring couples names provided by MDRN Photobooth Company;
  6. Photographer for the duration of the 2.5 consecutive hours provided by Lexine Photographie and 80 professional edited photos delivered in high resolution through an online private gallery;
  7. Individually packaged meal in a box for guests – bride and groom to select their choice of appetizer, main and cupcake provided by Dinewell
  8. Bar car services provided by Dinewell as follows: three (3) drinks per person, one (1) mini bottle of sparkling wine at each place setting for toasting, two (2) additional drinks per person (all mini cans of wine, beer, mixed drinks);
  9. On site wedding coordinator;
  10. Door man for touchless entry;
  11. Bathroom attendant for COVID cleanliness; and
  12. One (1) night standard accommodation for the Winner at a junior suite at The Westin Ottawa (11 Colonel By Drive, Ottawa Ontario, K1N 9H4) Valid until October 24, 2021.
- (b) The Prize has an approximate value of nine thousand nine hundred and ninety-five Canadian dollars (CDN \$9,995.00).
- (c) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (d) The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within two (2) business days once such Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out

herein. **Winner must arrange and coordinate the fulfilment of the Prize directly with Chic and Swell Inc.**

## **5. PRIZE CONDITIONS.**

- (a) Winner must be available to get married on the Wedding Date. Should Winner be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.
- (b) Winner shall provide to the Station with a copy of the marriage license by October 2, 2020 failure to submit same before the deadline, may result in forfeiture of the Prize.
- (c) Winner will be responsible for all incidental costs and expenses not explicitly included in the Prize, officiant, transportation to and from the venue, additional photographer services (CDN\$399.00 + tax per hour), accommodations, documents necessary for the wedding ceremony, taxes, gratuities, wedding gown, bridesmaid dresses, groom suit, telephone calls, in-room charges and any other expense of personal nature, and any other expense not explicitly included in the Prize.
- (d) In the event that, due to the COVID-19 pandemic, there are government regulations in place restricting social gatherings at the time of the Wedding Date, the Sponsors will make best efforts to coordinate a rescheduled date for the event with the Winners. If the Sponsors are unable to reschedule and provide the Prize because of such regulations or related circumstances beyond their control, then the Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.
- (e) Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- (f) The Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

## **6. WINNER SELECTION.**

One (1) Winner shall be selected as follows:

- (a) On September 25, 2020 at 3:00 p.m. ET, four (4) entrants will be selected by the Sponsors and/or the Sponsors' representatives (the "**Judges**") based on the following equally weighted criteria: (i) creativity; and (ii) uniqueness of their love stories (the "**Criteria**") as the potential finalists (each a "**Finalist**").

Listeners will be invited to vote online for their favourite Finalist on the Contest Website from September 28, 2020 6:00 a.m. ET until October 1, 2020 at 11:59 p.m. ET. Online voting is open to the general public and is limited to one (1) vote per person per day. Votes are subject to verification and will be declared invalid if they are reproduced, falsified, altered or tampered with in any way. **VOTES WILL BE CONSIDERED, HOWEVER; VOTES WILL NOT DETERMINE THE WINNER.**

- (a) On or about October 2, 2020 in Ottawa, Ontario, one (1) Finalist will be selected by the Judges based on the Criteria and taking into consideration the voting results. Before being declared a Winner, the selected entrant shall be required to comply with the Contest Rules and sign and return the Release (described below).
- (b) The Judges, in their absolute discretion, shall select the Winner based upon the above Criteria. The decisions of the Judges shall be final and binding and may not be challenged in any way.
- (c) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors and the quality of the Work submitted as judged against the Criteria.
- (d) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE NO LATER THAN OCTOBER 2, 2020 AT 5:00 P.M. ET AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (e) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

7. **RELEASE.** Winner will be required to execute a legal agreement and release ("**Release**") that confirms Winner's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the Sponsors, Facebook and their respective parent companies, subsidiaries, affiliates and/or related companies and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the "**Releasees**") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) grant to the Sponsors of the unrestricted right, in the Sponsors' collective or individual discretion, to produce, reproduce, display, publish, convert, post, serve, broadcast, communicate by telecommunication, exhibit, distribute, adapt and otherwise use or re-use the Winner's name, statements, image, likeness, voice and biography and the Work, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within two (2) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

8. **INDEMNIFICATION BY ENTRANT.** By entering the Contest, each entrant releases and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the

entrant or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from: (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the entrant's participation in the Contest, without limitation.

9. **RIGHTS CLEARANCE.** By providing the Work to the Sponsors in connection with the Contest, each entrant shall retain all right, title and interest (including copyright) in and to the Work and shall grant to the Sponsors a worldwide, gratuitous, irrevocable, and non-exclusive licence to copy, modify, produce, reproduce, display, publish, exhibit, distribute, convert, adapt, post, serve, broadcast, communicate by telecommunication, transmit and otherwise use or reuse the Work for use in all media now known or hereafter devised in perpetuity beginning on the date of entry, including, but not limited to, in connection with the administration, promotion and exploitation of the Contest. Sponsors assume no responsibility for any claims of infringement of rights to copyright, privacy, personality or otherwise, and all such liability shall remain with the entrant. Sponsors reserve the right to exclude any Work for any reason whatsoever, including but not limited to, on the basis of concerns relating to the rights of third parties, including but not limited to privacy, copyright, defamation, rights of personality, obscenity or hate speech, as determined by Sponsors in their sole discretion.
10. **LIMITATION OF LIABILITY.** The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Website.
11. **CONDUCT.** By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Website throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors and Judges, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest, and/or the Contest Website or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person.
